GENERAL RULES OF THE SHOW

Tentative Start Time : 9:00 A.M.

1. Show will be held regardless of weather; rides will be delayed if lightening occurs.
2. Management reserves the right to split, cancel, combine classes as entries warrant, to add/change officials and arenas. Number of rides for the show is limited. Entries are accepted on a first-come first-served basis.
3. Ribbons / prizes through sixth place. Plus **Special Prizes for Special Performances !**
4. All show entrants (AND PARENTS/LEGAL GUARDIANS of riders under 18 years of age) must complete and sign the ENTRY FORM and AGREEMENT AND RELEASE WAIVER. Submit both with payment and proof of negative **Coggins** on participating horse(s) **dated after November 7, 2008.**
5. Indicate on ENTRY FORM your rider status - open, amateur, junior/ young rider.

DEFINITIONS :

Open : Professional rider, i.e. one who receives compensation (not necessarily money) for riding or training horses, instructing riders.

Junior : Rider 17 years of age or less as of December 1, 2008.

Young Rider : Rider 15 to 20 years of age as of January 1, 2009.

Adult Amateur : Non-professional rider 21 years of age or older as of Dec. 1, 2008.

6. All classes will be ridden in a 20 x 60 meter arena EXCEPT Green As Grass, Intro, CT & some Tr Level Classes **may** be ridden in a 20 x 40 meter arena if excessive entries.
7. Green As Grass & Intro Classes are open to Amateur and Junior/Young Rider horse/rider combos who have never shown above Training Level and may not show above Training Level Test 2 at this show. Others may show in these classes riding hors de concours.
8. CLOSING DATE :Entries must be **Postmarked by 11/2 or handed in by 11/3/09.**
9. LATE ENTRIES and CHANGES after closing date will be accepted if feasible and will be assessed a Late Fee of \$10.00 per entry or Change Fee of \$5.00 per change.
10. REFUNDS FOR CANCELLATIONS : **BEFORE CLOSING DATE:** Entry, Grounds, Stabling fees will be refunded for horses or riders unable to compete for physical reasons as verified by a vet or physician certificate. **BETWEEN** Closing Date and 12:00 PM two days before the show : fees will be refunded with vet or physician certificate AND if ride times can be filled. **No Refunds for cancellations after 12:00 PM two days before the show.**
11. RIDE TIMES : **TENTATIVE** ride times available from Secretary and e-mailed after noon two days before the show. **Official Ride Times** available 6 PM the day before the show and posted on the show grounds . Riders will be contacted if times change significantly.

12. SCHOOLING : The show grounds will be available for schooling after Noon on the day before the show. The competition arena will be closed at some point for final set-up. Check with the Secretary for closing time.
13. **HARD HATS MUST BE WORN AT ALL TIMES when mounted.** For younger riders (under 18 yrs) this means an approved safety helmet with harness attached. Adult riders and Jr/YRs at 4th Level and above may show in a derby, bowler, or top hat at their own risk.
14. NON-COMPETING HORSES may be brought to the grounds for show environment experience IF SPACE ALLOWS (call Secretary), entry form and waiver are completed, Coggins requirements are met, Grounds fee (\$10) and Non-Competing Horse fee (\$15) are paid. Longeing / riding of this horse is allowed if done by the designated handler and does not interfere with competitors or their horses. Bridle numbers will be issued and must be worn.
15. CHILDREN must be closely supervised by a responsible adult at all times.
16. DOGS of a pleasant nature are allowed on grounds BUT must be leashed AND in hand OR kenneled at all times.
17. TESTS : **2007 USEF, USDF 2007 Intro & Freestyles; 2006 USEA, 2006 HDS (GAG).** If you need copies of tests check USEF at www.usef.org, USDF at www.usdf.org, HDS at www.houstondressage.org, USEA at www.useventing.com or contact the Secretary.

Maximum fence height 2 ft. Trot work is rising. Transitions to/from halt may be thru the walk. Tests may be called. Refusal = error of course.

A Enter working trot X Halt, salute. Proceed working trot C Track right MXK Change rein over Fence # 1. Return to working trot after jump A 20 m circle left Before F Turn on line to Fence #2. Return to working trot after jump and proceed toward M C Medium walk HB Free walk (x2) B Medium walk F Working trot Between A & K Working canter right lead KXM Change rein over Fence # 1, land in working canter M Working trot Between C & H Working canter left lead E Large ½ circle left over Fence # 2. After jump, proceed straight ahead Opposite M Working trot C Circle 20 m letting the horse gradually chew the reins out of the hands at working trot rising. Before C gradually take up the reins C Straight ahead HXF Change rein over Fence # 3. Return to working trot before F A Down Centerline X Halt, salute. Leave arena at free walk on a loose rein.
