### **GENERAL RULES OF THE SHOWS**

Tentative Start Time : 9:00 A.M.

1. Show will be held regardless of weather; rides will be delayed if lightening occurs.
2. Management reserves the right to split, cancel, combine classes as entries warrant, to add/change officials and arenas. Number of rides for the show is limited. Entries are accepted on a first-come first-served basis.
3. Ribbons will be awarded through sixth place.
4. All show entrants (AND PARENTS/LEGAL GUARDIANS of riders under 18 years of age) must complete and sign the ENTRY FORM and AGREEMENT AND RELEASE WAIVER. Submit both with payment and proof of negative **Coggins** on participating horse(s) **dated after February 28, 2009**.
5. Indicate on ENTRY FORM your rider status - open, amateur, junior/ young rider (21 yrs or less as of Jan 1).
6. All classes will be ridden in a 20 x 60 meter arena EXCEPT Green As Grass, CT, Intro & some Tr Level Classes may be ridden in a 20 x 40 meter arena if entries are excessive.
7. Green As Grass & Intro Classes are open to Amateur and Junior/Young Rider horse/rider combos who have never shown above Training Level and may not show above Training Level Test 2 at this show. Others may show in these classes riding hors de concours.
8. CLOSING DATE :Entries must be **POSTMARKED** by **Monday, February 22** or **Handed In** by 5 P.M. **Tuesday, February 23, 2010**.
9. LATE ENTRIES and CHANGES after closing date will be accepted if feasible and will be assessed a Late/Change Fee of \$5.00 per entry or change.
10. REFUNDS FOR CANCELLATIONS : **BEFORE CLOSING DATE**: All fees will be refunded. **BETWEEN** Closing Date and 8 AM of the Friday before the show : Entry, Grounds, Stabling fees will be refunded for horses or riders unable to compete for physical reasons as verified by a vet or physician certificate AND if ride times can be filled. **No Refunds for cancellations after 8 AM of the Friday before the show**.
11. RIDE TIMES : **TENTATIVE** ride times available from Secretary after noon three days before the show and will be e-mailed. **FINAL RIDE TIMES** will be posted on the show grounds and available by 3 P.M. the day before the show.

12. SCHOOLING : the show grounds will be available for schooling after Noon on the day before the show. The competition arena will be closed at approximately 5:30 PM for final set-up.
13. **HARD HATS MUST BE WORN AT ALL TIMES when mounted**. For young riders (under 18 yrs) this means an approved safety helmet with harness attached. Adult riders and Jr/YRs at 4<sup>th</sup> Level and above may show in a derby, bowler, or top hat at their own risk.
14. NON-COMPETING HORSES may be brought to the grounds for show environment experience IF SPACE ALLOWS (call Secretary), entry form and waiver are completed, Coggins requirements are met, Grounds/Stabling Fees and a \$15 Non-Competing Horse fee are paid. Longeing / riding of this horse is allowed if done by the designated handler and does not interfere with competitors or their horses. Bridle numbers will be issued and must be worn.
15. CHILDREN must be closely supervised by a responsible adult at all times.
16. DOGS of a pleasant nature are allowed on grounds BUT must be leashed AND in hand OR kenneled at all times.
17. TESTS : 2007 USEF, 2007 USDF Intro & 2007 Music, **2010 USEF CT**, 2006 HDS GAG. Prix Caprilli tests available at website. Dressage Trail Test is homemade. If you need copies of the tests contact the Secretary.
